

### The Mission of The Cornerstone Society

Our mission is twofold:

- 1. To assure an enduring financial legacy that will outlive the donors and nurture succeeding generations at Peakland Baptist Church
- 2. To offer church members and friends the opportunity to be good stewards of their accumulated assets

We will carry out this mission through regular efforts to keep the concept of planned giving in the minds of our congregation. For many, this will be an educational process; for others, it will be simply informational. As is the established spirit of our church, no pressure of any kind will ever be a part of any activities of The Cornerstone Society.

The value and annual performance of the endowment supported by the members of The Cornerstone Society will be reported at the church's annual meeting.

Everyone who creates any type of long-term planned-giving relationship with Peakland Baptist will be a member of The Cornerstone Society. We understand that there may be supporters who prefer anonymity, but we hope that you will identify yourself to our Planned Giving Committee, who will assure you that your name will not be revealed or published. The Church does not need to know the amount of your planned gift, just your intention to give.

# How to go about doing whatever *you* want to do regarding your plans for Peakland Baptist's future:

There are *many* ways you can set aside a specific amount to go to your church when you are no longer writing checks yourself:

- Your Will. It is essential that each individual have his and her own will.
- **Insurance**. You can designate a part of an existing policy or create a new policy.
- **A Trust Fund**. There are many types to enable you to achieve your specific goals.
- **Annuities.** These, like trusts, can be funded with cash, stocks or bonds, or real estate.
- **Retirement Plan Assets**. A portion of an IRA or 401(k) can easily be set aside.

**There are more.** Begin the process of deciding which suits you best by talking with any member of the commitee, with your attorney, CPA, or other tax advisor.

An excellent resource is the Virginia Baptist Foundation. Peakland Baptist has contracted with their team of financial specialists to manage our endowment, and these professionals will assist you with estate planning and with the preparation of your will.

The Virginia Baptist Foundation has been assisting churches such as ours for the past 82 years. Today over 200 churches utilize this excellent and highly successful organization.
